7	MATERIAL SUPPLY	Free issue material will be supplied to vendor's works at BHEL's cost and dispatching the drilled tube sheet after completion of job will be in vendor's scope, that means the charges of delivering the job to BHEL's store to be borne by vendor.			

8	PENALTY	In the event of delay in supply of goods,a penalty of 0.5% per week or part there of shall be levied on the undelivered portion subject to a maximum of 10% of the order value.			
9	PAYMENT	Payment will be made within 45 days for SSI units on presentation of certificate and 90 days for others, from the date of receipt and acceptance of material in BHEL/against goods receipt.			
10	VALIDITY OF THE OFFER	Offers must be kept valid for a period of 90 days from the date of opening of the tender. In the event of acceptance of the offers the price quoted should remain firm till the completion of job.			
11	INSPECTION	a. Stage / Final-inspection will be done at your works on receipt of information by BHEL QC/ Customer inspector/BHEL appointed agency. TPI inspection charges will be borne by BHEL. b. Necessary facilities shall be provided for TPI / Customer / BHEL inspector for inspection during and after fabrication and also at the time of final assembly and testing.			
12	DRAWINGS	a)These drawings are the property of BHEL. Copying or circulating or misuse of these drawings or parts of it by vendor is not permitted and may have to face legal consequences. b)Drawings will be given for estimation purpose only. However complete drawings will be given at the time of placement of order.			
13	TOOLS	Tools,gauges,jigs & fixtures and instruments will not be supplied by BHEL.

15	QUALITY ASPECT	HP Heater Tube Sheets to be supplied strictly as per Drawing /Scope and under proper Inspection.			

16	GUARANTEE	Equipment shall be guaranteed against all manufacturing defects for a period of 24 months after supply or 18 months after commissioning whichever is later. Defects noticed shall be replaced / rectified at free of cost by the supplier.			
17	LOADING/UNLOADING FACILITIES	You must have adequate material handling facilities for safe unloading of raw materials/loading of finished products.Vendor must furnish the details of the cranes in house and their capacity.			
18	INSPECTION	On receipt of the goods at our BHEL site, the goods shall be subjected to inspection. Our acceptability of the goods shall be final.			
19	CONSEQUENCES OF REJECTION	Any rejection arises by mishandling of tubes sheets or for machining defects or any kind of damage by which the tubes are not fit for use, the cost of each tube plate shall be recovered along with taxes & duties as per BHEL norms from the bank guarantee being furnished by vendor			
20	CONSEQUENCES OF FAILURE TO DELIVERY	In case of the supplier's fail to supply the goods within the due date, BHEL shall be entitled to cancel the order or impose penalty.			
21	RIGHT OF CANCELLATION	BHEL shall have the right to cancel the contract wholly or in part in case it is obliged to do so on account of any decline, diminution, curtailment or stoppage of business.			
22	BANK GUARANTEE	Vendor should furnish bank guarantee from any nationalised bank to the tune of Rs.40 lakhs in case of placement of order as per BHEL format.			
23	PACKING	All finished jobs should be well covered with a suitable rust preventive materials(Plastic sheets) and to be suitably packed before despatch. For any loss or damages arising out of improper packing the vendor will be held responsible.			
24	TAXES & DUTIES	Applicable taxes and duties to be mentioned in the offer.			
25	SCRAP COST	Scrap cost will be deducted from the vendor for each tube sheet as per BHEL norms.			

26	PRICE BID OPENING	After final clearance of technical and commercial conditions, vendors will be intimated the date of price bid opening/Reverse Auction.

30	NUMBER OF DEEP HOLE DRILLING MACHINES & THEIR MAKE	Vendor shall furnish the information on the number of deep hole drilling machines they have in house and make of the same.			
31	REVERSE AUCTION	<p>BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA.
