TERMS & CONDITIONS OF CONTRACT

01. The bidding is in 2 stages i.e. (1) Technical cum commercial bid and (2) Price bid
02. The price bids of only those bidders will be opened who qualify the first stage.
03. Bidders are requested to comply with requirements like PF Regn., ESI Regn. Labour licence etc. However, if the appropriate authorities raise any such requirement/claim/challan, the bidder will have to fulfill all requirements for which no financial burden shall be passed on to BHEL. The full burden will have to be borne by the bidder.
04. The bidders are required to quote rates for providing & operating **3 Nos., Brand New 'Tata 'Indigo' Diesel Operated Taxi, with A.C. along-with well dressed Drivers, White seat covers, Fuel, Taxi Permit, all legal clearances from RTO, Labour authorities, Insurance cos. Etc. for transporting of VIP/Customer etc. relating to BHEL.** The **rates should be** in Rupees for minimum 750 Kms run in one month and per Kilometer (Rs./KM) rate for run above 750 Kms. in figures & words as well (Approximate 250 Kms). There should be no cutting or over-writing in the price bid. Please ensure while filling the price bid.

05. For the purpose of deciding the lowest bidder the following formula shall be used to decide L1:
Effective rate of item No.1 = Rate of item No. 1(a) + Rate of item No. 1(b) x 250 kms. = L1 Rates
06. Payment will be made to Bidder on the basis of actual Kilometers completed to different places. In case actual kms. in one month are less than 750 kms. minimum charges of 750 Kms. shall be paid. In case actual kilometers completed are more than 750 kms, payment will be made on the basis of minimum charges plus extra kms. run @ of accepted per Km. rates of award letter. Bidder should submit bill on monthly basis supported with log book and other related documents. The service provider will submit proof of Service Tax deposit challan along with the bill if applicable.
- 07 Monthly bills will have to be submitted in the format. The Pool Supervisor will make appropriate necessary corrections before forwarding the bills for payment. Bills not submitted in the standard format will not be accepted for which the contractor will be held responsible.
08. The bidder will have to raise monthly bills for the service rendered; these bills shall be scrutinized by BHEL before payment. Failure to submit the bills within 3 months of the service rendered may disqualify the bidder from any claims. BHEL shall not be responsible for making any payment for which bill has not been raised/submitted to BHEL Jhansi. The bills should be in the format in which price bid has been made. Fuel Price Variation amount and Service Tax, if any, shall be paid extra. For fuel price variation bill, please refer Clause 15.
09. BHEL assures a minimum business of **750 KMs (Seven Hundred Fifty Kilometers)** per month This condition is however subject to satisfactory fulfillment of all other terms & conditions. The billing period will begin from the 1st/15th day of a calendar month. Bidder should strive to place the vehicle/taxi on 1st/15th day of month.

10. The **validity of the contract** shall be Two years from date of LOI/Contract and may be extended further on mutually agreed terms and conditions.
11. The ordering/contract will be finalized on lowest technically qualified bidders only. The quantity may be increased or decreased at the time of ordering.
12. Offers shall be accompanied with **Earnest Money Deposit (EMD)** of Rs.40,000/- Forty Thousand only) in the form of Demand Draft, in favour of BHEL Jhansi or BHEL cash deposit receipt. Bidders can also submit one time EMD by depositing Rs. 2,00,000.00 (Two Lacs) in cash office & certificate of one time EMD may be enclosed along with tender. Offers without EMD shall be liable to be rejected. The EMD shall be refunded to the unsuccessful bidder(s) after award of work by BHEL and acceptance by the successful bidder.
13. **Security Deposit (SD)**: Security deposit as per Works Policy 2008 **Para-8.2** will be collected from the successful bidder **before start of the work** in the form of either Cash or Pay order or DD or NSS or KVP or Bank Guarantee. The directives given in BHEL Works Policy 2008 shall be fully followed. EMD of Rs.40,000/- will be treated as Security Deposit for the contractor to whom the contract is awarded. The S.D will be refunded to the contractor after satisfactory completion of the work and after making necessary recoveries, if any.
14. Successful bidder will pay the Stamp Duty on Security Deposit as per government Rules.
15. **Fuel Price variation clause:**
 - (a). The rates agreed between BHEL and the bidders will remain firm during the currency of the contract. However the rates will increase/decrease by 30% of the percentage increase/decrease in the average retail price of Diesel prevailing on the date of tender opening (Techno Commercial Bid-Part-1). Any increase/decrease so allowed to the bidders will be extra/less and form the part of basic rate (Per Kilometer Rate of Taxi). This increase/decrease will be done, only quarterly, as under:-
 - (b) The rates at which the work is awarded initially will remain firm till the end of that quarter (31st March, 30th June, 30th September & 31st December) without any PVC. For example, if rate contract is effective from 1st January, rates will remain firm up to 31st March but may change from 1st April and will remain same up to 30th June. If rate contract is effective from 30th March, rate will change from 1st April which will remain same up to 30th June.
 - (c) The retail sale price (RSP) of Diesel applicable for Jhansi District obtained from the office of IOCL/HPCL/Reputed dealers shall be the basic for calculation of Price Change of taxi per kilometer rate.
 - (d) Percent increase/decrease in taxi rate shall be 0.30 times of percent increase/decrease in average retail sale price (RSP) of diesel w.r.t. base rate indicated in tender.
 - (e) Example:
If the RSP of diesel are as following:-
Assumed retail sale price in Rs 50.00/per ltr. as on Base date on 15th January ,2015
On 1st February, 2015 - Rs. 52.00/per ltr (Revised Rate).
On 1st March, 2015 - Rs. 53.00/per ltr (Revised Rate).
On 1st April, 2015 - Rs. 55.00 per ltr (Revised Rate).
Average: (52.00+53.00+55.00)/3 = Rs. 53.33 /per ltr (Revised Rate)
Percentage increase w.r.t. RSP on base date: (53.33-50.00)/50.00 x 100 = 6.66 %
Percentage change in Taxi per kilometer rate will be: 0.30 x 6.66% = % 1.998
This increase in Per Kilometer Taxi Rates shall be applicable in the period from 1st April, 2015 to 30th June, 2015.
 - (f) **Taxi per kilometer fare increase/decrease on any other account shall not be permissible.**

DEDUCTION

16. The driver of the vehicles should be well behaved and courteous with the passengers. He should display restraint and wisdom in dealing with excited passengers. In case of misbehavior by the driver, a penalty of upto Rs.500/- can be imposed for each occasion. In case there are multiple repetitions with a particular driver, he will have to be changed.
17. The driver of the vehicles will not be changed without prior permission of TPT Incharge/user.
18. One extra set of cleaned & ironed white seat covers/Towels will have to be kept ready for providing during VIP visits. In case of failure to do so, BHEL will get the same prepared and deduct the amount from the bills apart from recovering a penalty of Rs.500/-.
19. The bidder will have to provide two pairs of clothing to each driver which shall include one light blue shirt with piping, one navy blue trousers (pant) & belt and one pair of black shoes. The shirt should have a label showing the name of the Firm on the left and a name plate on the right side of the shirt showing the name of the driver. If bidder fails to complete anything, BHEL will complete it at the risk and cost of the bidder.
20. In case the uniform is not worn, penalty @ Rs.10 per day is liable to be levied. In case this continues for more than 30 days, the amount of Rs.500/- can be recovered back.
21. The driver will have to be provided with a mobile phone. He will keep the mobile phone charged and in fully operative condition. Failure to keep/keep ON the phone would entail a penalty of Rs.50/- per day subject to maximum Rs.500/- per month per vehicle.
22. The contact person mentioned in Part-'A' of this bid will have to meet the Pool Supervisor at least once every fortnight for obtaining feedback about the operation of the taxis. The instructions issued by the Pool Supervisor will be noted down by the contact person in Two Copies, one each for the contractor and BHEL. Non-reporting in any fortnight can result in a penalty of Rs.100/- for each lapse. Similarly the contact person will meet the Transport Executive once every alternate month and discuss the issues for smooth running of the contract. Failure to comply with this provision can result in a penalty of Rs.100/- for each lapse.
23. In case of breakdown of the taxi on any day, another taxi will have to be provided. In case of failure to provide another car, a penalty @ Rs.500/- per day will be imposed. This will be allowed only for maximum 7 days, after which management reserves the right to terminate the contract at the risk & cost of the bidder. In case of absence of driver, another driver has to be arranged immediately with intimation to TPT Incharge.
24. The front & rear wind screens should have a sticker reading "ON BHEL DUTY". The taxi will be parked in BHEL for which suitable place will be provided. In case of failure to do so, BHEL shall, deduct the charges from the contractor's bills and recover a penalty of Rs.100/- per day.

25. The vehicle will remain on duty for 12 hours in a day. The actual duty hours will be intimated separately. Failure to report at the specified time can result in a penalty of Rs.10/- for each lapse subject to maximum one hour late, beyond which the penalty shall be Rs.100/-. In case of habitual late coming grater penalty can be imposed. In case, vehicle remains on duty after 8.00PM for 1 hour or more, Night Charges @ Rs.50/- per night shall be paid extra.
26. Placard indicating name of Guest, name of Company etc. will have to be displayed by the driver at the Railway station for receiving incoming guests. The Transport Pool In-charge will give details from time to time. Failure to comply with this provision may result in a penalty of Rs.100/- per incident. Each vehicle has to keep two sketch pens, white sheets, blade & cello tape for writing the name of the arriving guest and paste it on the front wind screen. Failure to do so would invite penalty @ Rs.50/- per incident.
27. In case the vehicle goes out of U.P. State on BHEL duty, the service provider has to obtain road permit for the same. Expenditure incurred on this account shall be reimbursed along with the payment of bill on documentary proof. Failure to timely arrangement of permit would result in a penalty of upto Rs.500/- per incident.
28. The Car will have to be maintained by the contractor in good running condition which includes at least the following:
- Minimum noise of engine and body while running;
 - Tyres with proper treads;
 - Inflated Stepney;
 - Working headlights, tail lamps, indicators, speedometer, milometer, temperature indicator etc;
 - Proper paint on the outside;
 - Good condition of bumpers;
 - Upholstery in good condition including washed and ironed white seat covers;
 - Proper locking of all doors;
 - Proper closing and opening of all windows;
 - Dusting of dashboard, rear board, matting, windscreen, windows and body.
- Failure to maintain the same would invite penalty @ 1% of bill for each failure for the duration of the failure/lapse.
29. While on Station duty, taxi will have to be parked near Main Porch/Enquiry/Statues. Railway Station parking charges in Jhansi to be borne by the contractor. Parking charges outside Jhansi City shall be reimbursed on documentary proof. Failure would result in a penalty of Rs.50/- per incident.
30. During out station trips, cash for fuel/driver's personal expenditure, other State permit charges etc. will have to be provided in advance by contractor otherwise a penalty of upto Rs.1000/- per incident can be imposed by apart from actual charges incurred. On repeated failure, greater penal action can be taken.
31. The contractor has to ensure that filling of the fuel in the vehicles is done form the petrol pump situated near BHEL. In case it is found otherwise, penalty of Rs.100/- per occasion can be imposed on the contractor.

32. The bidder will have to maintain a logbook provided by TPT Pool and the signature(s) of the authorized person who travel will have to be obtained to certify the trips; failure to obtain the name & signature can deprive him of payment for the trip. The logbook will be the Company's property and driver has to keep it in the safe custody. No unauthorized person should be allowed to travel in the taxi when on BHEL official duty. Failure to comply with this provision can result in non-payment of the trip.
33. **Contractor/Operator will have to fulfill all legal obligations regarding minimum wages, PF, ESI, Pollution Norms, Motor Vehicle Act, Service tax etc. as may be applicable to him. The vehicle should have valid taxi permit issued by R.T.O., Jhansi. The vehicle must be comprehensively insured for driver, passengers & the third party for the period of the contract.**
34. The vehicle may be deputed for election duties. During this period, payment shall be made as per contract after deducting the cost of fuel and other reimbursement received, if any, by the driver from the Election authorities.
35. The vehicle(s) may be required to go outside Jhansi. Permit charges etc. of other States be reimbursable against documentary proof.
36. Driver should have valid Driving Licence for Commercial vehicles. Driver without licence will not be permitted.
36. The contractor has to abide by all laws, rules & regulation applicable to this type of work. Ignorance of the same does not entitle him to any concessions or claims.
37. Any dispute(s) or difference(s) arising out of or in connection with the contract shall to the extent possible in the first instance be resolved amicably between the contractor and BHEL.
In case a dispute is not resolved, the same shall be referred for conciliation by an officer of BHEL. In case, it still remains unresolved, the dispute will be referred for arbitration by an officer of BHEL. (In case arbitration by an officer of BHEL's is not acceptable, the same could be entrusted to any mutually agreeable common functionary or an independent person). The arbitrator will give his award within the shortest period. The award of the arbitrator shall be final, conclusive and binding on both parties.
The arbitration proceeds shall be conducted in accordance with "Indian Arbitration and Conciliation Act 1996 or any statutory modification thereof. Language of the Arbitration proceedings shall be in English. The venue of Arbitration shall be Jhansi, India. The court of Jhansi shall have exclusive jurisdiction.
38. Any matter of dispute arising out of or in connection with this contract shall be under jurisdiction of Jhansi Court only.
39. The Contractor has to make an agreement with BHEL in the format prescribed only on Rs. 100/- Non-Judicial Stamp Paper.
40. In case of non satisfactory performance of the contract, BHEL shall have a right to cancel the contract and/or forfeiting the security deposit.
