### **Part A: Instructions to the Bidders**

1. **Bidders shall quote One Total Lumpsum Price for the entire scope of work in the format given in PART C in the price bid.** Any other entry elsewhere in the price bid shall be treated as Null and Void.
2. BHEL has fixed the Factors of individual items of Schedule of Quantity w.r.t. the total lumpsum price (as quoted by the bidder in Part C). These item wise factors are available in Chapter-XII of Volume I TCC. Also schedule of items & Quantities are also available in Chapter-XII of Volume I TCC.
3. Based on the pre-fixed factors and the quoted total lumpsum price, individual item rates shall be derived by BHEL by multiplying the respective factors with total lumpsum price.
4. Item rates thus derived shall be rounded off to zero decimal places. Rounding off may lead to minor variation in the total lumpsum price. This will be adjusted by BHEL by very minor adjustment of the derived item rates. This will be done to arrive at the exact quoted/accepted Lumpsum price given by the bidder.
5. For only the convenience of bidders, BHEL has issued an excel sheet with all requisite formulae as detailed above. However this excel sheet shall not form part of contract document
