3. Prices shall be valid for **3 Months** from the date of opening of technical bid.
4. Part offer shall be rejected i.e. bidder shall quote for all the chemicals.
5. **Payment terms:** 100% within 45 days from the date of receipt & acceptance of material at destination and submission of original invoices with complete documents to BHEL PSWR HQ NAGPUR. Payment will be released by EFT (electronic fund transfer) mode only.
