- 1.1 Preventive maintenance i.e daily, weekly, fortnightly, monthly, quarterly & checks of all fork lifters.

- 1.3 Breakdown maintenance of all fork lifters.
- 1.4 Filling the log book/ job card on shift basis, filling the checklists after carrying out reventive/ shutdown maintenance & updating the preventive/ shutdown/ breakdown maintenance entries & parts consumed in the computer present in the work area.
- 1.5 Upkeeping & maintenance proper cleanliness the work area/ stores.

- 1.8 On Sundays or national holidays work is to be done only if an emergent situation arises.
- 1.9 PF & ESI of your manpower is entirely your responsibility.
- 1.10 Safety of all your manpower is entirely your responsibility. Uniform (Including safety shoes,safety gadgets) will be provided by you. You must ensure compliance with all safety and health regulation in force during the period of contract. You will have to ensure that only those persons will be employed for carrying out the job those are adequately trained in safety and technical aspects as required for the job.
- 1.11 All the tools shall be provided by BHEL.
- 1.12 All the consumable materials and spares used in maintenance of fork lifters shall be arranged by BHEL.
- 1.13 As and when overhauling of engine and transmission system of fork lifters required same shall be carried out by BHEL against separate approvals. Scope for the above work shall recommended by vender after detailed inspections.

**3. PERIOD OF CONTRACT**

The period contract will be for one year.

**4. DEPLOYMENT OF MANPOWER**

The contractor has to provide sufficient manpower of experienced Automobile mechanic/electrician and suitable helpers to assist the total work during contract period.

**5. TERMS OF PAYMENTS**

- 5.1 Payment will be made every month on submission of work done during the period duly verified by erection in charge.
- 5.2 Income tax will be deducted from the each bill. This will be as per guideline of govt. of India. At present 2% income tax will be deducted.
- 5.3 Service tax will be paid, this will be as per guideline of govt. of India. At present service tax is 12.36% contractor should be submitted Challan copy of service tax deposit.

**6. GENERAL TERMS & CONDITIONS**

- 6.1 Contract shall keep all staff orderly in proper uniform and arrange to provide them the work of repair/ manufacture of spares in their idle times.
- 6.2 No foreign/ used/ unused/ scrapped/ broken parts shall be left on area.
- 6.3 After award of contract the subjected work shall be started within one week from the due date of award in line with tender conditions.
- 6.4 All used/ worn-out/scrapped/ replaced spares/ parts shall remain the property of BHEL, Jhansi. These items shall be return to WE&S store.
- 6.5 BHEL, Jhansi shall not be liable for any compensation what so ever in the event of accident/ injury to the persons employed by the contractor however, first aid facility shall be rendered free of cost.
- 6.6 Utmost care should be taken by the contractor to repair the items proper way & with quality workman ship so as to satisfy requirements as per factory act, 1948 section 19 & U.P. Factories Rules 1950 Rule 55-A & subsequent amendments enforced from time to time.

**CONTRACTOR'S OBLIGATIONS**

**A) CONTRACTUAL:-**

**Towards selection, control and supervision of employees:-**

1. Contractor shall decide the number of employees to be deployed for execution of the work awarded to him and he or his authorized representative will be solely entitled to instruct such about the manner of carrying out the work as per the prescribed specifications and quality plan.
2. Contractor shall supervise the work allotted to him and to be carried out by his employees.
3. Contractor will ensure that the job is executed through his employees on his rolls and under no circumstances the contractor will deploy any casual employee to carry out the job nor shall sub-contract the job without prior written permission.
4. **Age of workers:** The contractor shall not employ any person who has not completed his 18 years. Also age of worker deployed should not exceed 60 years.
5. Contractor to ensure that the employees deployed in the premises of BHEL are physically and mentally fit and do not have any criminal record. Such employees should possess requisite skill, proficiency, qualification, experience etc. acceptable to concerned department.
6. **Discipline:** The Contractor shall be responsible for the discipline of his own employees deployed under the contract. In case of any loss to the BHEL Jhansi on account of indiscipline of employee then such loss shall be assessed and recovered from the running bills of the contractor or from the security deposit.
7. The contractor, on advice of authorized BHEL official, shall immediately remove any person employed by him, who may in the opinion of such authorized BHEL official is involved in misconduct. Such person shall not be re-employed by the contractor without prior permission.
8. Contractor will keep watch on his employees and he will be liable for any pilferage / loss to BHEL due to acts of omission and commission by his employees. Similarly, liability for any compensation to outsiders on account of any act of omission and commission by the employees deployed by the contractor shall lie exclusively with him.
9. Contractor to ensure that all precautions are taken for safety of his employees and equipments.
10. **Record Keeping:** Contractor to maintain appropriate records of his employees deployed to carry out the job(s). Contractor shall maintain neatly written, complete and legible registers, records, reports and returns for inspection by various authorities at short notice.

11. **Uniform**: The contractor shall be responsible to provide to his workers uniform and safety gears such as shoes, helmet and PPE . The uniform should be dark blue trousers and light blue shirt for males and dark blue trousers/salwar and light blue kurta/ kameez/top for female. The uniform should have logo of the contactor's firm/ company which shall be affixed by the contract labor on the left side of his pocket. The uniform shall be kept in neat, tidy and wearable condition. The stitching and logo charges should be borne by the contractor. Contractor shall ensure that the employees are in neat and tidy uniform and safety gear on duty. Penalty of 5% of monthly bill may be imposed if the workers are not found in prescribed uniform and safety gears.
  12. **Bus Pass** : Contractor may apply for providing bus pass facility to his workmen. BHEL will consider such applications based on merits and availability of seats. Contractor would be responsible for depositing bus pass charges and penalties (if applied) of his/her workmen/staff etc. BHEL would have the right to deduct/recover the same in case of default by the contractor/supplier.
  13. In the event of termination of contract for any reason whatsoever, the contractor shall withdraw all his employees from the establishment of BHEL. In case contractor decides to terminate services of his employees, he should settle all terminal dues required.
  14. **Tools, tackles and materials** : Contractor shall provide to his employees all tools, tackles, material, equipments as specified in contract and maintain the same to carry out the job under the contract at his risk and cost. BHEL shall not have any liability for these tools, tackles, equipments or material.

- (c) If there is a discrepancy between words and figure, the amount in words shall prevail unless the amount expressed in words is related to an arithmetic error, in which case the amount in figure shall prevail subject of (a) and (b) above.
- (d) If there is such discrepancy in an offer the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
